Column Name	Column Description
AS_OF_DATE	The last day of the four quarters of data represented in this dataset.
MEMBER_LAST_NAME	The last name of the member at the end of the reporting period.
MEMBER_FIRST_NAME	The first name of the member at the end of the reporting period.
MEMBER_MI	The middle initial of the member at the end of the reporting period.
ENROLLMENT_DATE	The date that the member enrolled in the pension fund.
EMPLOYER_NAME	The name of the employer reporting at the end of the reporting period.
LOCATION_CODE	The code that identifies the location of the employer reporting at the end of the reporting period.
LOCATION_NAME	The county in which the employer reporting at the end of the reporting period is located, or REGIONAL, or STATEWIDE.
PENSION_FUND_ID	The identifier of the pension fund for which this data is being reported.
PENSION_FUND_NAME	The name of the pension fund for which this data is being reported.
PENSION_GROUP_ID	The identifier of the pension subgroup if applicable, or N.
PENSION_GROUP_NAME	The name of the pension subgroup if applicable, or NOT APPLICABLE.
VETERAN_STATUS	The veteran status of the member for pension purposes.
SERVICE_YEARS_QTY	The full years of service in the pension fund credited to the member.
SERVICE_MONTHS_QTY	The months of service in the pension fund for the most recent partial year credited to the member.
TOTAL_MONTHS_QTY	The total months of service in the pension fund credited to the member (where each full year of service equals twelve months).
CURRENT_EMPLOYER_SALARY_AMT	The salary eligible for pension credit reported by the current employer for the current location during the most recent four quarters.
ALL_EMPLOYERS_SALARY_AMT	The total salary eligible for pension credit reported by all employers for all locations during the most recent four quarters.
25_YEAR_DATE	The date upon which a member achieved twenty-five years of pension service, otherwise blank.

Column Name	Column Description
20_YEAR_STATUS	The status that indicates whether the member is exempt from Chapter 78. "YES" indicates the member attained 20 years of service before the Chapter 78 effective date (June 28, 2012) and is exempt from allowance-based health benefit premium calculations if the member retires with at least 25 years of service. All other members are "NO".
MEMBERSHIP_TIER	The category of retirement benefits available based on the pension fund enrollment date of the member.
